

**ROSE QUARTER EVENT
ENTER-TO-WIN SWEEPSTAKES OFFICIAL RULES**

(1) NO PURCHASE NECESSARY TO ENTER OR WIN. SWEEPSTAKES VOID WHERE PROHIBITED.

(2) Eligibility: Sweepstakes open to legal U.S. residents, 18 years of age or older at the time of entry, who live within the state of Oregon and Western Washington. Employees (former and current), agents, successors and assignees of Rip City Management LLC (“Sponsor”), each event promoter and performer, and each of their respective affiliated companies, subsidiaries, and advertising or promotional agencies (collectively with Sponsor, the “RQ Entities”), and the family members, agents, successors or assigns of, and any persons domiciled with, such employees, are not eligible to enter. **(3) How to enter:** **(a)** go to www.rosequarter.com/entertowin, fill out all required information and submit the entry form. By entering, each entrant agrees to be bound by the terms relating to the use of the website, including its [Privacy Policy](#); or **(b)** go to the Rose Quarter business office (located at One Center Court, Suite 200, Portland, OR 97227) during normal business hours, and on a 3"x5" card or piece of paper provide your full name, mailing address, telephone number (including area code), and e-mail address, and give it to the receptionist telling the receptionist you want to enter the “Rose Quarter Event Enter-to-Win Sweepstakes”. **LIMIT OF ONE (1) ENTRY METHOD PER PERSON PER EVENT.** **(4) “Sweepstakes Term”:** the Sweepstakes will begin on or about September 18, 2017 and the final entry date will be determined by the last Event entry date for the final scheduled Event in June 2018, but in no event shall such final entry date be later than 11:59pm PPT on July 1, 2018. **(5) Winner Selection:** Each Sponsor designated public concert, family show, or other public entertainment event which is officially scheduled at the Rose Quarter shall be an “Event” for purposes of this Sweepstakes; provided, however, that such Events will specifically exclude all Portland Trail Blazers and Portland Winterhawks games, private events and all other events designated as excluded by Sponsor which may occur during the Sweepstakes Term. The entry period for each Event will be posted on the Enter-to-Win page prior to the respective Event (each an “Event Entry Period”). Approximately 48 hours after the end of the Event Entry Period for each respective Event (each an “Event Draw Date”), a minimum of one (1) potential winner will be chosen by random drawing from all eligible entries received during the respective Event Entry Period. Each potential winner will be notified by telephone or e-mail within 72 hours of their respective Event Draw Date. In the event a potential winner does not respond within two (2) days of attempted notification or declines the prize, another entrant will be randomly drawn from the remaining eligible entrants, up to a maximum re-draw of three (3) times after which Sponsor reserves the right to not award the prize for the respective Event. Odds of winning will depend on the number of eligible entries received during the applicable Event Entry Period for each respective Event as noted above. Non-winning entries from one Event will not be rolled over into the next Event. **(6) Prizes:** After confirmation of eligibility and acceptance each winner will receive two (2) entry tickets to the respective Event for which their entry was drawn. The approximate retail value (“ARV”) of each prize will vary based on the then-current market price for a ticket to the respective Event; provided, however, the minimum ARV for the prize for any Event will be no less than thirty dollars (\$30.00) and no more than a maximum ARV of three hundred dollars (\$300.00) (each a “Prize”). **LIMIT OF ONE (1) PRIZE PER PERSON OR HOUSEHOLD PER EVENT.** The total number of prizes will be based on the number of Events which occur during the Sweepstakes Term; provided, however, Sponsor will award no less than a total of twelve (12) prizes during the Sweepstakes Term. Prizes have no cash value, no substitution, cash equivalent or transfer of any prize permitted except at Sponsor’s sole discretion to offer an option for a prize of comparable or greater value. Each winner is solely responsible for reporting and payment of any applicable federal, state, local, and municipal taxes, and any and all other costs and/or expenses relating to or incurred in conjunction with the Sweepstakes and/or with use of a prize, including without limitation, costs for transportation, meals and parking. Each winner agrees that the prize awarded is personal to such winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated or otherwise conveyed. No guest of a winner will have any independent rights to a prize or any portion thereof and each guest must accompany their respective winner at all times during use of such prize. Each winner’s guest may be required to sign a release and waiver to receive benefits of the prize or any portion thereof, as applicable or determined by Sponsor in its sole discretion. Sponsor and management personnel of the Rose Quarter reserve the right to remove or to deny entry to any winner and/or guest of such winner if any such person violates the foregoing restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person during any Event. Each winner and his/her guest agree to abide by all rules and policies of the Rose Quarter facilities and are subject to removal for non-compliance or unruly behavior. **(7) Miscellaneous:** By entering the Sweepstakes, each entrant agrees to follow the Official Rules and hold harmless and indemnify Sponsor, and each of the NBA Entities against any and all liability, damages or causes of action (however named or described), with respect to or arising out of either (i) entrant’s participation in the Sweepstakes; or (ii) the receipt or use of any prize awarded in the Sweepstakes. **(a)** In consideration for being awarded a prize, each winner and his/her guest hereby agrees and consents (where legal), without further notification, authorization, compensation or remuneration of any kind, to the use of such person’s name and/or likeness in any and all advertising, promotions and other publicity conducted by Sponsor and/or any RQ Entity. **(b)** Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Sweepstakes as solely determined by Sponsor. In the event the Sweepstakes is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor, which corrupts or impairs the administration, security, fairness or proper operation of the Sweepstakes, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Sweepstakes. Should the Sweepstakes be terminated prior to the stated expiration date, Sponsor reserves the right to award any prize based on the entries received prior to the termination date. **(c)** By entering the Sweepstakes and/or acceptance or use of a prize each entrant/guest

agrees that (i) any and all disputes, claims, and causes of action arising out of or in connection with the Sweepstakes, or any prize awarded, shall be resolved individually without resort to any form of class action; (ii) any claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with participation in the Sweepstakes, but in no event attorney's fees; and (iii) under no circumstances will any entrant be permitted to obtain any award for, and entrants hereby waive all rights to claim, punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than damages for actual out-of-pocket expenses. Solely for purposes of compliance with the terms and conditions provided in these Official Rules and use of any prize, any guest of any winner will be deemed as an entrant/participant in the Sweepstakes, regardless of whether such guest submitted an official entry. **(d)** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any entrant and Sponsor, shall be governed by, and construed in accordance with the laws of the State of Oregon, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of the laws of any jurisdiction other than Oregon. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein. **(e)** Sponsor is not responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor. In the event of a dispute, all electronic entries will be deemed to have been submitted by the owner of the electronic account from which they were sent. For these purposes, an electronic account holder shall mean the natural person assigned to such electronic account by the Internet access provider, online service provider or other organization responsible for assigning electronic addresses for the domain associated with such account.
